THE MUSEUM ENDEAVORS TO SET EACH EMPLOYEE'S SALARY WITHIN THE SALARY RANGE BASED ON THE EMPLOYEES DEMONSTRATED LEVEL OF COMPETENCIES (E.G., SOMEONE WHO HAS MANY YEARS OF EXPERIENCE IN A POSITION AT ANOTHER MUSEUM WOULD BE PLACED ABOVE THE MEAN SALARY FOR THAT POSITION AND SOMEONE WHO IS NEW TO A POSITION WOULD BE PLACED BELOW THE MEAN AND WOULD MOVE AS COMPETENCIES ARE DEMONSTRATED).
